To the parents/guardians of eligible bus students and those requesting busing;

We have a new online application process to re-apply for bussing. You can log into your Parent Connect, go to Profile-Basic Demographics and review your address, bussing information and daycare information. Then go to the Forms tab and find the Transportation Application form and select your response.

- PC - Yes, same bussing, pay online (This is through Parent Connect, will be available to pay between August 15th and August 31st)
- SCH - Yes, same bussing, pay csh/chq (Send cheque or cash to the school)
- DD - Yes, same bussing, direct debit (Must attach a voided cheque or bank information form from your bank and fill out the Pre-Authorized Debit form – found on the Seven Oaks School Division website under Departments-Transportation)
- NO - No longer require bussing
- CHG - Yes, bussing, changes required
Changes could be your address, change of school, pick up or drop off locations. Please fill in the student name and school, and then only the changes required in the bottom section of the form.

Please respond by Friday, May 15th, 2020 and submit payment forms, where applicable, to the school.

Please note that the Division has changed their transportation policy. Kindergarten – Grade 6 students now must be 1.6 km to be eligible for bussing.

All students living 1.6 km or further that are now going into Grade 7 are no longer eligible to be transported at no cost according to the Seven Oaks School Division Policy.

Transportation on a user fee basis will be provided only if space is available on an existing bus route. There is a minimum distance requirement of 1.2 km to be able to purchase a seat.

One K to 5 and one 9 to 12	\$ 1,159.00
One 6 to 8 and one 9 to 12	\$ 1,224.00
Two or more Grades 9 to 12	\$ 1,448.00

Fees are determined by the grades of the two oldest students. The third student (in families of 3 or more) receives transportation for free using the Family Maximum fee schedule. (A discount, if applicable, is already removed from the Family Maximum.)

PAYMENT OPTIONS

- **Exact Cash** (offices do not have change) in full, can be made at the school office or the Transportation Office
- **Cheque** One (1) payment in full, (money order or bank draft) **made payable to: Seven Oaks School Division. This cheque can be post dated no later than August 30, 2020.**
- **Interac** One (1) transaction (in full) in person only at the Transportation Office
- **Visa/MasterCard**
 - a) Payable One (1) transaction (in full) in person at the Transportation Office
 - b) Payable online in Parent Connect (In full or quarterly payments on Sept 1st, Nov 1st, Jan 1st, Mar 1st)
- **MONTHLY PAYMENTS:**
Pre-Authorized Debit Form completed and attached with a void cheque or bank confirmation letter
10 equal monthly payments starting with the **1st payment due on September 1st** and then **every month from October 1, 2020 to June 1, 2021** (or the first business day closest to the 1st of the month.)
10 business days notice prior to the beginning of the month must be given if changing banking information.

Policies and Procedures 2020 - 2021

INTRODUCTION

The Seven Oaks School Division believes that student transportation services must be provided at a level which will provide equal and reasonable access to education for all students within the divisional community.

ELIGIBILITY

All Kindergarten to Grade 6 students whose distance from their home address to their assigned or catchment area school within the Division is greater than 1.6 kilometers shall be transported. Where students eligible for grants are not transported, as in the case where a program outside the Division is followed, their parents or legal guardians shall receive a transportation allowance equal to the provincial grant.

In addition, the following will also be transported at no cost:

- Kindergarten to Grade 6 students whose most direct walking distance from home or from a designated feeder daycare to an assigned or catchment area school equals or exceeds 1.6 kilometers.
- Kindergarten to Grade 6 students who attend a day care/babysitter that equals or exceeds 1.6 kilometers from the student's assigned or catchment area school and is on an existing bus route.
- Students in Kindergarten to Grade 12 residing in the R.M. of West St. Paul and the R.M. of St. Andrews who live 1.6 kilometers or more from their assigned or catchment area school.
- Students who have been authorized by the Superintendent (or designate) to be transported to their assigned or catchment area school
 - a) because of situations related to safety,
 - b) on compassionate grounds.

NON-ELIGIBLE STUDENTS

On a cost recovery basis and conditional upon space being available on an existing bus route, Kindergarten to Grade 12 students who live under 1.6 kilometers from their assigned or catchment area school with preference being given to those students farthest away from their assigned or catchment school. Space availability will be determined by age with younger students receiving first priority for available discretionary space. It is understood that if a student eligible for transportation requires the space, the user pay student may be displaced with a two-week notice.

BUS FEES

Effective for the 2020 - 2021 school year, the transportation fees shall be:

- \$ 535.00 for Kindergarten to Grade 5 students
- \$ 600.00 for Grade 6 to Grade 8 students
- \$ 724.00 for Grade 9 to Grade 12 students

Fees for families with several children riding the bus will be reduced by \$100.00 per family. There is no reduction for high school students.

As our bus service runs all year we are not able to accommodate winter bussing.

Non-eligible students requiring transportation after September 1st are required to pay full fees for the entire year.

CANCELLATION OF BUS SERVICE/REFUNDS

- If you are moving out of the division, closer to the school, or have obtained space in your school's day care and no longer require transportation, we would appreciate 10 day's notice to cancel the bus prior to the first of the month. Bus fees are based on one whole school year. (September to June). We will not refund or discount fees if the bus is not taken or used for the entire year.
- Should the bus assignment be cancelled by Seven Oaks School Division, a prorated refund will be made.
No other refunds will be made.

10 business day's notice prior to the end of the month is required for changing banking information. An email must be sent to transportation@7oaks.org

OUT OF CATCHMENT AREA STUDENTS

Where students choose to attend, through the "schools of choice" provision, a school outside of the assigned or catchment area, they must pay a transportation user fee. Such fee is contingent on space being available on an existing bus route.

NON-RESIDENT STUDENTS

All Non-Resident students (including those in feeder day cares) who fall under "schools of choice" regulations, must pay the transportation user fee. Such fee is contingent on space being available on an existing bus route.

FINANCIAL HARDSHIP

Fees may be waived for financial hardship by the Superintendent. Combined Family Income Tax verification must accompany the application.

PROCEDURES

- **All students, regardless of eligibility, are required to complete the response form on Parent Connect requesting a bus.**
- Should you need to make changes to your child's busing, (i.e. phone numbers, home address, daycare address, school, cancelling busing, etc.) please update this information with your child's school. Please allow one week to 10 days for changes to take place.
- New Kindergarten routing information will be mailed home at the start of the school year by the Transportation Department.
- Grades 1 – 12 can check their bus information on Parent Connect in the last 2 weeks of August.

RIDERSHIP GUIDELINES

The Division is responsible for the safety of students using school bus transportation from the pick-up point to the school and the drop off point on the route home.

Parents/Guardians are responsible for ensuring the safety of students to and from the school bus pick-up and drop-off points.

Please note the following rules:

1. Transported students will be picked up and dropped off at a designated stop each day. Alternate pick-up or drop-off points are not permitted.
2. **Students must be at their designated stop 5 minutes prior to pick-up time.** It will be the parent's responsibility to get their child to school should they miss the bus.
3. If a parent is not waiting at the stop when their child is brought back from school, the child will be returned to the school for the parent to pick up.
4. Regularly transported students are permitted to only ride their assigned buses.
5. Students other than those approved for regular transportation are not permitted to ride the school buses.

Expectations of Students

It is the school bus rider's responsibility to:

1. Be respectful; of people and property, e.g. use appropriate language
2. Act in a safe manner, e.g. remained seated while on the bus, speak in quiet voices, listen to instructions from patrols and drivers.
3. Refrain from eating on the bus.

Bus drivers will deal with initial and minor concerns about safe and respectful behavior on the bus. Ongoing or major concerns will be reported to the Principal.

While the Division is obligated to provide transportation to those who qualify, it must be understood that there are limits to this obligation. The Board, through its Administration, reserves the right to suspend the privilege of transportation to those pupils who, through their actions on a bus endanger the health and/or safety of themselves or others.

School Bus Safety

To make school bus ridership as safe as possible, all students are required to participate in a School Bus Ridership Safety program two times each year. The program includes emergency bus evacuation drills.

SEVERE WEATHER AND BUS CANCELLATION

Sometimes, severe weather causes us to cancel buses. The general rule is that if the temperature combined with the wind chill is -45 C or colder at the Forks (as posted by Environment Canada at 6:00 a.m.), we cancel buses for the whole day but schools usually remain open. All metro Winnipeg school divisions follow one system, based on this rule.

We will post an alert message on the Seven Oaks School Division website home page if buses are cancelled. Major radio stations will also announce busing cancellations. They usually broadcast cancellations about every 15 minutes. You can also check local television stations and the Internet.

Morning cancellation of buses remains in effect for the remainder of the day, including noon and at dismissal time.
