We kindly ask that when entering any building associated with the Rainbow Stage facility, that you:

- Keep to the right when traveling through common areas.
- Masks are welcome but only mandatory when stated by the event coordinator.
- Avoid touching surfaces unnecessarily.
- Children (under age 12) must be under adult supervision at all times.
